5. Verification Process

Before disclosing any information, the Owner will:

- Verify the identity of the Third Party.
- Provide Copy of Owner's Driver's License

6. Confidentiality

The Third Party agrees to:

- Keep all disclosed information confidential.
- Use the information solely for the purposes stated in this agreement See Item #1.
- Implement reasonable security measures to protect the confidentiality of the disclosed information.

7. Term of Agreement

This agreement is valid from the date of signature and will remain in effect until written notice of cancellation is provided by the owner, or the owner no longer owns the property listed above.

8. Termination

Either party may terminate this agreement by providing written notice to the other party and to the Management office. Upon termination, the Third Party must return or destroy all confidential information.

9. Indemnification
